

# INDEMNITY FORM

I, the undersigned, do hereby:

1. Acknowledge the presence of wild and dangerous animals, reptiles, birds and insects present in and associated with game reserves and/or game lodges. I appreciate that there is a potential risk of suffering bodily harm, injury, death and/or loss to property. Such risk may arise as a result of an encounter with and/or the presence of such animals and/or reptiles and/or birds while present at any place/game reserve or location involved in the course.

2. Acknowledge and declare that I decided to join a Wild Spirit Course fully aware of the danger and risk inherent in the presence of wild and dangerous animals, reptiles, birds and insects as well as transport and activities I may be exposed to.

3. On behalf of myself, my spouse, my common law wife/husband, my children, whether minor or adult, any dependents or relatives and/or any persons accompanying me to Wild Spirit Course, waive and abandon all claims whatsoever arising against Wild Spirit, their associates, servants, employers, directors, facilitators, shareholders and/or any other person connected, whether directly or indirectly with the operation of Wild Spirit, and any facilities accommodated on the properties belonging to Wild Spirit. The waiver and abandonment relates to any claim arising out of harm, injury, death or loss suffered whilst entering on, or exiting the premises or property of Wild Spirit and whether arising from an act or commission or omission on the part of those hereby indemnified or any of them.

4. Indemnify and hold harmless Wild Spirit, its Vets, associates, servants, facilitators, employees and/or any other person connected, whether directly or indirectly with the operation and running of Wild Spirit and fellow guests and invitees from any and all claims of whatsoever nature which may arise on behalf or myself, my spouse, my common law wife / husband, my children, whether minor or adult, any dependents or relative and/or any persons accompanying me to Wild Spirit whether as my invitee or otherwise, who may suffer injury or loss whilst entering on or exiting the premises or property of Wild Spirit and whether arising from any act or commission or omission on the part of those hereby indemnified.

5. Declare and warrant that I am authorized to make and give the aforementioned waiver of claims and indemnity.

6. Acknowledge that any emergency medical treatment arranged or paid for by Wild Spirit, employer, vets or any person connected shall be at the discretion of the owners of Wild Spirit and without prejudice to their rights and without any admission of liability on their part.

7. I understand that several activities take place outdoors so weather can change the program and activities may be cancelled.

8. Acknowledge that I understand the aforementioned acknowledgement, waiver and indemnity and that I fully understand the meaning and effect thereof and that I am bound thereby without limiting time.
