I do hereby confirm, undertake and agree that all activities in proximity to wild animals involve risk and I appreciate that the services and facilities provided by Wild Spirit company may expose me to injury and/or loss over which the Company cannot exercise control.

Such activities include any recreational activities such as game drives, game capture and capture and treatment of wild animals (including but not limited to the accommodation, field inspection and /or travel in any form of transport used in connection therewith) excepting only that caused by the Company's negligence.

I acknowledge that I am well acquainted with and fully aware of the real dangers and risks that are associated with game reserves and/or game lodges from the presence of wild and dangerous animals and plants and the real risk of bodily harm, injury, death and/or loss to property which may arise as result of an encounter with and/or the presence of wild animals and plants whilst on the premises or property of the reserve/ facility. I specifically confirm that I am aware of the existence of free roaming dangerous wildlife.
2. I also acknowledge that excursions can be undertaken on foot and by car and that those activities carry the risk of dangerous encounters with wild animals, car accidents due to the rough terrain to be covered or accidents due to unforeseen circumstances.
3. I agree to abide by the rules and regulation as determined by you, which are applicable to my presence on any animal reserve and that I understand the rules.
4. I agree that any other extra activity that I might engage during the course will under my full responsibility.
5. I agree to keep you, the director sand all personnel indemnified and to hold you harmless against any claim on account of any loss or damage, death, injury, accident or legal costs suffered by me arising from any cause whatsoever arising whilst the Wild Spirit course.
6. I further accept that all statements made and/or information given by the Company are provided in good faith and shall not be construed as in any way affecting or waiving the Agreement.
